Ethics Education and Consultation includes teaching medical students and clinicians; managing the KC Regional Ethics Committee Consortium (now in our 34th year); presenting educational webinars and interviews; developing and curating COVID-19 resources for providers including the website which contains 4000+ reports, guidelines, policy briefs, program resources, and audio/video recordings of interviews, lectures, and symposia. In 2019, there were more than 509,200 page views, up from 341,663 in the prior year. It also includes leading ethics consultations at The University of Kansas Health System (2019 was our 12th year of this collaboration) and for individuals who request consults directly. We also work with Kansas City University of Medicine and Biosciences partnering in the education of their 860 medical students on two campuses.

Advance Care Planning & Serious Illness builds on CPB's legacy work in end-of-life care, focusing on increasing participation in advance care planning in diverse communities and on accelerated medical decision-making in long-term care settings. In 2019 we conducted community workshops in libraries, hospitals, people's homes, nursing homes, as well as in corporations as part of their benefit offerings. A program designed with and for African Americans was also continued following the unexpected death of our colleague, Dr. Richard Payne, who died suddenly following a cancer diagnosis. This program in in partnership with faith communities.

4c (Code:) (Expenses \$ 68,188. including grants of \$ 0.) (Revenue \$ 3,537.)
Emerging Issues & Systems Change includes issues in healthcare that raise ethical concerns and need for systems change. Current focus is on ethics surrounding COVID-19, artificial intelligence, and providing a voice in research and treatment for people who live with chronic pain. As COVID-19 swept into the US, the Center has tirelessly provided webinars regarding topics ranging from advance care planning in nursing homes which have been hard hit by the virus, to saying good bye to a loved one remotely, to managing the moral distress affecting clinicians and other hospital workers as well as family members who are distanced from loved ones.
